# **COMMUNITY TRAFFIC CONCERNS/COMPLAINTS - Phone Calls Received**

## Oswego Police Received Complaints For The Following Violations:

- Truck Weight Limit Sign Requested on Harvey Road. Researched with Jennifer Hughes.
- Crosswalk @ Fifth & Bluegrass Concern over crosswalk safety. Details were conducted.
- Speeding on Garfield. Speed study conducted. Speeding complaint unable to be verified. Asked citizen to assist with providing vehicle info on those she believes is speeding.
- Three complaints of speeding on Heritage after a child was hit riding his bike. Speed study was conducted and could not substantiate the claim. Further research determined that the area was on a curve and the perception of speeding was an issue. A van parked in the area 525 Heritage was creating an obstruction on the curve and research on past crashes all indicated an obstruction being a contributory cause. Van was moved.
- Complaint about traffic light not functioning properly at Douglas and Longbeach. Resolved.
- Route 30 & Route 34 intersection. Complaint about vehicles disobeying the traffic light and running the red light. Details were done and stops were made to rectify the issue.
- Complaint of speeding on Morgan Valley Drive. Speed study in queue. Pending.

# **INVESTIGATIONS**

# **Investigation Highlight**

Brandon Ramsey, who attempted to burn down his parent's house, was arrested on a warrant for a class 2 felony residential arson warrant. We received approval on a felony theft in which a female fraudulently obtained 6 visa gift cards, valued at \$3,000, from Wal-Mart. The offender had clear working knowledge of Wal-Mart's cash registers, based on her ability to obtain the

activated cards. We learned she had performed the same scam at a Wal-Mart in another jurisdiction.

Detectives Spears and Guisti attended ICAC Investigative Techniques class in Champaign. This class is through the AG's office and will allow our detectives to better investigate internet crimes against children, including the peer-to-peer computer sharing of child pornography. Detective Wicyk assisted Yorkville and Sugar Grove PD with a forensic extraction of cell phones that contained evidence of crimes. Detective Wicyk is one of only four officers in Kendall County certified to perform cell phone extractions.
