INVESTIGATIONS

Investigation Highlight

In July 2014, Detective Burgwald was able to identify a similar pattern from two 2012 felony retail theft cases that some new information had been brought forward from one of the cases. A suspect who had been identified was then found to be incarcerated on a probation violation from an unrelated conviction. Detective Burgwald traveled to an Illinois prison to conduct an interview and obtained incriminating statements from the suspect. The Oswego retail theft cases are from two separate stores in town and we worked with their loss prevention departments during the initial investigations.
