INVESTIGATIONS

Investigation Highlight

On September 11, 2014 Patrol officers responded to an arson call early in the morning at a residence on Route 34 where some vehicles were set on fire and others attempted to be set on fire. Initial responding officers and then an evidence technician did a good job of finding and securing evidence at the scene. Detectives followed up with two separate interviews on that date. A primary suspect and several accomplices were identified, and after several more interviews over the next several weeks enough evidence was gained to secure four felony and one misdemeanor charge against the subjects involved. The combined efforts of the responding patrol officers and detectives lead to some very good leads and showed the cooperation between the two divisions in getting this case moving forward quickly.
