INVESTIGATIONS

Investigation Highlight

In May of 2011, the Oswego Police Department took a Financial Exploitation of the Elderly and Theft report from a citizen that had involved a female subject who created a fraudulent power of attorney and the subject then utilized that to conduct banking matters in the victim's name. During the course of the investigation, Detectives worked with the Kendall County States Attorney's Office and a bank to assist in the investigation. Numerous hours were spent conducting interviews and researching financial documents. At the conclusion of the investigation, charges were obtained on the female suspect. She was charged with multiple financial related crimes which included multiple felony charges.

In October of 2014 this case was resolved with a plea agreement that included a guilty plea to a felony theft charge and also restitution to the victim of over \$18,000.00.
