MISCELLANEOUS ENFORCEMENT & EDUCATIONAL EFFORTS

We continued to partner with Oswego East High School, Oswego Community Bank and Oswego Ace Hardware to provide driver safety messages on their respective marquees. The messages include, "You Drink & Drive, You Lose", "No Seatbelt, No Excuse", "Drive Now Text Later", "Look Twice, Save a Life", "Over the Limit, Under Arrest." This educational campaign helps support our enforcement efforts generated through the Sustained Traffic Enforcement Program (S.T.E.P.) Grant.

The Oswego Police Department teamed up with the Kendall 10 Theater to display safety message ads on the movie theater lobby televisions (Theater Lobby Media). The purpose of these ads is to promote safety reminder messages throughout the winter season. Traffic Officer Bailey created an ad for recruiting for the upcoming Citizen Police Academy Class (CPA). The purpose of the CPA is to have Oswego residents have a better understanding and knowledge of their local police department. These ads will run starting in December 2011 through early 2012.

The Oswego Police Department has partnered up with the Illinois Department of Transportation (I.D.O.T.) to help encourage people to participate in the "Yellow Dot Program". This programmed was designed to help first responders to assist victims in the critical hour following a crash. The concept is that a yellow decal will be displayed in the rear windshield of a vehicle. This sticker alerts the first responder to check the glove box/compartment of the vehicle for a yellow card listing detailed medical information and any health issues the occupants of the vehicle may have. INVESTIGATIONS

Investigation Spotlight

During the week of January 23rd, the Kendall County State's Attorney's Office successfully prosecuted Zachary Reyes for a murder that occurred in Oswego in December of 2009. The Oswego Police Department investigated a drive by shooting that occurred at Long Beach and Douglas Roads. The suspect vehicle was stopped by police just after the shooting. A passenger, Zachary Reyes was later arrested and charged with the murder of Jason Ventura and the attempted murder of Eduardo Gaytan and Jorge Ruiz. After a 4 ½ day trial, a jury found Reyes guilty of all charges.
