#### MISCELLANEOUS ENFORCEMENT & EDUCATIONAL EFFORTS

We continued to partner with Oswego East High School, Oswego Community Bank and Oswego

Ace Hardware to provide driver safety messages on their respective marquees. The messages include, "You Drink & Drive, You Lose", "No Seatbelt, No Excuse", "Drive Now Text Later", "Look Twice, Save a Life", "Over the Limit, Under Arrest." This educational campaign helps support our enforcement efforts generated through the Sustained Traffic Enforcement Program (S.T.E.P.) Grant.

In addition to the safety messages posted on the above mentioned marquees, the department's "Click It or Ticket" banner was placed along Route 71.



Originally, the mission of the SADD chapter was to help young people say "No" to drinking and driving. Today, the mission has expanded. Students have told us that positive peer pressure, role models and other strategies can help them say "No" to more than drinking and driving.

And that is why SADD has become a peer leadership organization dedicated to preventing destructive decisions, particularly underage drinking, other drug use, impaired driving, teen violence and teen depression and suicide.

The Oswego Police Department, in conjunction with Illinois Students Against Destructive Decisions & MCQ 3 Inc., will host a One Simple Decision Driving Simulator at the Oswego Police Department Prairie Fest booth. Texting while driving is a major distraction on our roadways today. People need to be more aware of their lack of attention to activity on the roadway. One Simple Decision driving simulators offer interactive simulation of impaired/distracted driving to include "live texting".

The simulator will be available Friday June 15<sup>th</sup>, 2012 from 10:00 A.M. till 4:00 P.M. and Saturday June 16<sup>th</sup>, 2012 from 9:30 A.M till 3:30 P.M. People wishing to participate need to have a valid driver's permit or license with them. Each simulation will take approximately 5 minutes. Sign-up for the simulator will be on a first-come first-serve basis at the booth only (no phone call reservations will be taken). For more information visit www.ilsadd.org.
