Smart Trailer Log for August 2010

During the month of August, the S.M.A.R.T. Trailers were utilized during the annual Art Fair Event. Additionally, in an effort to improve safety at the intersection of Route 34 and Route 30, the message board was deployed to Route 34 west of the intersection and programmed with the safety message, "Slow Down-Arrive Alive."

The message board was used along Route 71 in the construction zone in front of the Oswego High School. The message board informed motorists that school started August 25th and they should expect delays due to increased traffic volume. The message encouraged motorists to use an alternate route.

The trailers were deployed to four different locations throughout the Village. These locations were selected in an effort to educate the motoring public of the posted speed limit for each roadway. No speed studies were conducted at these locations.

Community Concerns

Quarterly Traffic Crash Summary

The 2^{nd} quarter crash summary showed there was an 11% decrease in total crashes through the 2^{nd} quarter of 2010.

Saturation and Special Enforcement Details

In August there were five saturation patrols completed by members of the Traffic Enforcement Unit. Additionally, Traffic Unit members completed a total of 18 directed patrols.

Again in August, Traffic Officers picked two subdivisions for their directed patrol assignments. The HOA liaison officers assigned to the subdivisions selected by Traffic Officers were informed of the additional enforcement efforts planned for their subdivision. This enforcement approach is intended to supplement liaison officer's traffic efforts within their assigned subdivision.

Traffic Officers completed directed patrols in the following subdivisions; Ashcroft, Brookside, Churchill, Lakeview and Park Place. Below are the results of their efforts:

A total of 55 officer hours were worked during IMaGE Grant details. 88 traffic stops were completed during this time.

The above results reflect six details that were completed during the August portion of the IMaGE Grant campaign. This included four Seatbelt Enforcement Zones (2 @ Route 34 & Route 30 and 2 @ Route 34 & Douglas Road). The aforementioned intersections were targeted as a means to reduce crashes at each intersection. The IMaGE Grant, saturation patrols, traffic safety campaigns and educational campaigns have all been used to reduce crashes at these intersections. As a result of these combined efforts, the intersection of Route 34 & Route 30 has experienced a 40% reduction in crashes through the 2nd quarter

2010 and the intersection of Route 34 & Douglas Road has experienced a 27% reduction in crashes during the same period.

Pedestrian Crosswalk Details

In August, we again implemented pedestrian crossing details in the downtown business district. These details are part of a campaign to educate motorists about the law requiring vehicles to stop for pedestrians in marked crosswalks. Below are the results of the two details completed.

Community Traffic Concerns

Our department continued to address areas that were identified as traffic concerns in previous months. There were no new traffic concerns communicated to us during the month. <u>Community Traffic Concerns – Department Website</u>

There was no website generated Community Traffic Concerns received this month.

Citizen Assisted Radar Monitoring Program

Alumni from our Citizen Police Academy completed two radar monitoring details. During each two hour details, CPAA members monitored the areas of Heritage Drive, Bluegrass Parkway, Prairieview Drive and Lombardy Lane. These locations were selected as means to determine whether additional speed enforcement is necessary and to support ongoing efforts in this subdivision.

As a result of these details, 4 courtesy letters (1 Heritage Drive, 3 Lombardy Lane) were mailed to motorists exceeding the posted speed limit by 8 or more mph. The radar monitoring program continues to be a useful tool in supporting our enforcement efforts.

CPAAA members were asked to evaluate two intersections and record the number of motorists who actually stopped at the posted stop signs. These intersections represent locations where we have received complaints of motorists disobeying the posted stop sign(s). Below are the intersections in question and the results of each evaluation:

N. Adams & North Street

As a result of previous complaints and the above evaluation of N. Adams and North Street, an Extra Patrol was created for the intersection. In September, the intersection of Linden Drive and Ashcroft Lane will be monitored by Officer Keith Wilson and the assigned HOA liaison officer for the Ashcroft subdivision.

Miscellaneous Enforcement & Educational Details

In preparation for the Labor Day Holiday Weekend, we partnered with the Oswego East High School, Oswego High School, Oswego Community Bank, Oswego Ace Hardware, The Knights of Columbus and Marcleys Mini Mart to provide driver safety messages on their respective marquees. The messages included, "Seatbelts Save Lives, Buckle", "No Seatbelt, No Excuse", "Slow Down – Arrive Alive", "Over the Limit, Under Arrest" and "Click It or Ticket". This educational campaign helps support our enforcement efforts generated through the IMaGE Grant. This two pronged approach is intended to improve motorist's driving behaviors and to increase safety on our roadways.





In addition to the safety messages posted on the above mentioned marquees, the department's "Click It or Ticket" banner was placed along Route 71.

On August 10th, the Oswego Police Department was one of many agencies which participated in a Route 34 Corridor Traffic Safety Enforcement Campaign. The campaign was coordinated by the Naperville Police Department. The focus of the campaign was on seatbelt, speeding and alcohol violations. During the campaign, Officers Stephen Bailey and Keith Wilson generated the following results:

On August 18th, the Oswego Police Department along with the Plainfield Police Department coordinated a traffic safety campaign along the Route 30 corridor. A total of nine law enforcement agencies participated in the campaign including; Kendall County Sheriffs Office, Will County Sheriffs Department, Crest Hill Police Department, Montgomery Police Department, ISP and Illinois Commerce Police Department and Joliet Police Department. The goal of the campaign was to identify seatbelt, speed and overweight truck violations. The aforementioned agencies issued a combined total of 241 tickets and 43 written warnings.

Sergeant Dan Kipper and Officers Stephen Bailey, Steve Lawrence and Keith Wilson participated in the campaign. Because the intersection of Route 34 and Route 30 has historically experienced a high frequency of crashes, much of our enforcement efforts were directed toward this intersection. Below are the results of Oswego's efforts:

In an effort to reduce traffic and increase safety along the Route 71 corridor in front of the Oswego High School (OHS), a media blitz was generated, which alerted area residents and District 308 parents/students of the expected delays due to the start of the school year and the ongoing construction in front of OHS. A press release was posted in the Ledger Sentinnel and placed on the Oswego School Districts, Oswego Police Department and Oswego Village's websites. Officers assigned as Homeowner Association (HOA) liaisons to residential areas were asked to forward the press release onto their HOA contacts.

School Zone details were created for the first 2 ½ weeks of the school year. Each day, both Traffic and Patrol Officers are assigned to monitor pedestrian and vehicular traffic at various schools within the Village. The officer's main purpose is to promote a safe environment by providing a presence within the school zone.
