The Village of Oswego will hold its regularly scheduled Committee of the Whole and Village Board meetings on Tuesday, July 14th with elected officials, staff, and the public participating remotely in compliance with the State's requirements. The Committee of the Whole will begin at 6 p.m. with the Regular Village Board meeting beginning at 7 p.m. (or immediately following the Committee of the Whole meeting). Village Hall will be open for the meeting; however, residents are strongly encouraged to watch or participate remotely due to there being a limit of fifty (50) persons gathering pursuant to the Governor's Executive Order. How to watch or join the meetings from home:

- Watch the webinar live at <u>StreamUS.oswegoil.org</u>. You will see the elected officials, staff members, and other participants who are attending remotely. If you access the video webinar on a smart phone, you will be prompted to download the Zoom app.
- Join our meeting by phone call. Call (312) 626-6799 just prior to the meeting. When prompted, enter passcode **508 193 215** from your phone. You will hear the audio of the meeting through our webinar service.

To give a comment at the meetings, you have multiple options:

- Email your comment to publiccomment@oswegoil.org by 4 p.m. on the day of the meeting. Your comment will be read aloud during the Public Forum portion of the Village Board meeting by a Village staff member. Please indicate, in the subject line of your email, what meeting body you would like your comments to be read aloud at. For example: "Public Comment for Village Board Meeting". The entire content of your written comments will be subject to public release. The Village of Oswego is under no obligation to redact any information.
- Give your comment live by phone. Email publiccomment@oswegoil.org or call 630-554-3259 by 4 p.m. on the day of the meeting and leave your name, address, phone number, and the topic on which you'd like to speak. Our staff will call you during the meeting and will put you on speakerphone so that you can give your comment live. Please be by your phone when the meeting begins at 7 p.m. We will let the line ring four times before moving onto the next speaker.

• You may also still give public comment in person. Residents are strongly encouraged to stay home and participate remotely, however, they may also attend the meeting in person. If attending, members of the public are required to stay six feet from any other person in the room and wear a face covering/mask.

As always, those giving public comment are asked to fill out the Public Participation form and abide by the Village's civility code, which is available on the Village's <u>website</u>.

FISCAL IMPACT:

FY 21 Budget includes \$750,000 in the Capital Improvement Plan for the entertainment venue project.

BACKGROUND:

On October 1, 2019, the Village Board approved Resolution 19-R-72, approving an agreement to accept the donation of ~3 acres of property at Lot 7 in Oswego Junction Phase 2. The donation agreement requires the Village to develop "a venue for outdoor live performance and music entertainment and events to be enjoyed by the public" on the site within 3 years. Since that time, the Village entered into contracts with Schoppe Design for land planning, Threshold Acoustics for an acoustical study, and Williams Architects for architectural and engineering design. In addition, in the spring the Village conducted an online community survey to identify opinions on how the

entertainment venue should be used, conducted stakeholder interviews, hosted a public open house on July 1, received written and online comments about the building elevations and site design, and held a public hearing on July 9 with the Planning and Zoning Commission (PZC).

The purpose of this agenda item is to finalize the architectural and site design prior to completion of construction documents and final engineering.

DISCUSSION:

The Village held a public open house on July 1 to present the design options publicly and ask for public input. Input was received from comment cards completed during the event or members of the public could complete the comment card online. A total of 145 comments were received, 95% of respondents self-report being from Oswego. Attached please find a summary of the comments, with further discussion below.

Architectural Design

During the June 9, 2020 Committee of the Whole meeting, Village Board members favored designs 1, 2 and 5 out of the five presented architectural option for the stage. Designs 1 and 2 were very similar, so Williams Architects narrowed the options down to a new Option 1 (combination of original designs 1 and 2) and a new Option 2 (previous option 5) – see below.

Option 1 is more traditional and received overwhelming support from the open house survey (84.1%). This option also has a smaller roof/stage covering (30' x 40 x 27') and an open back area.





Option 2 is a more forward-looking design that received little public support (15.9%). This option has a larger roof/stage covering (60' x 40' x 40') and a completely enclosed back area. Staff will report to the Board any feedback received by the PZC during Tuesday night's discussion.

Action Required: Staff asks the Village Board to form a consensus on which Option to direct Williams Architects to move forward into the design development and construction drawings phase.

Site Design

During the previous COW the Village Board also discussed the configuration of the entrance plaza and support building. As such, the public was asked which option they preferred – maintaining the entrance plaza to the south or switching places with the support building and moving it to the north. Most respondents were neutral on this (51.2%), with the current south configuration (29.5%) edging out switching them (19.4%). Staff will report to the Board any feedback received by the PZC during Tuesday night's discussion.






Which of the two bandshell options do you prefer? 132 responses

I personally am excited that such a venue will be available for our community, both as a source of arts and entertainment, and also as an affordable location for our various businesses and groups to perform.

- 1. As noted earlier, this project was originally presented as a no/low cost venue. Tens of thousands of dollars have already been spent at the cost of other Village budgets.
- 2. The parking area will not support the number of "expected" guests.
- 3. How will the Village recoup the costs for even maintaining this venue?

Stop wasting money on this. This should mean a lot coming from a musician and patron of the arts.

Your SPL calculations are WAY off if you are talking any kind of amplified show, excluding orchestra events. Minimum spl of a tribute show(for example) is 100db. Often pushing 120db spikes at about 30 meters. Just to give you a clue, when a drummer hits a snare(his main instrument) the actual hit makes between a 115 and 125 db at that point at 1 meter. Also the BASS on subs for shows tend to resonate more backwards off stage and to the sides

Next, reading through everything..how high is the stage? also, answering the questions on what stage to go with depends on where they hang points are for lighting and such. I can kinda see them in option 1 but option 2 doesn't look there is any. Option 1 looks like every other venue. Option 2 is unique. I like unique but option 1 is cool. Hard to decide all depends on hang points for functionality
