Meeting Attendance Instructions

In accordance with the State of Illinois Executive Order and Disaster Proclamation signed and filed on November 13, 2020 and for purposes of Public Act 101-0640, Article, 15 section 15-5, Executive Order 2020-07, 2020-33 and 2020-44 have been re-issued to amend the Open Meetings Act (5 ILCS 120/7(e)(4) finding that the public health concerns render in-person attendance of more than ten (10) people at a meeting not feasible. The amendment remains in effect for 30 days.

Public Act 101-0640 allows public bodies to conduct remote meetings under certain conditions. Each member of the public body participating by audio or video conference for a meeting held under these provisions is considered present at the meeting for purposes of determining a quorum and participating in all proceedings.

The Village of Oswego will hold the regularly scheduled Committee of the Whole and Village Board meetings on Tuesday, November 24, 2020 with Board members, staff, and the public participating remotely in compliance with the State's requirements. The Committee of the Whole meeting will begin at 6:00 p.m. with the Village Board meeting following at 7:00 p.m. Village Hall will be open for the meeting; however, residents are strongly encouraged to participate remotely due to the limit of ten (10) persons gathering pursuant to the Governor's Executive Order and Disaster Proclamation.

How to watch or join the meetings from home:

- Watch the webinar live at <u>StreamUS.oswegoil.org</u>. You will see the Board members, staff members, and other participants who may be attending remotely. If you access the video webinar on a smart phone, you will be prompted to download the Zoom app.
- Join our meeting by phone call. Call (312) 626-6799 just prior to the meeting. When prompted, enter passcode **508 193 215** from your phone. You will hear the audio of the meeting through our webinar service.

To give a comment at the meetings, you have multiple options:

- Email your comment to ttouchette@oswegoil.org by 4:00 p.m. on the day of the meeting. Your comment will not be read aloud during the Public Forum portion of the meeting. Instead, the emailed comments will be provided to all Village Board members and will be included in the meeting minutes. The entire content of your written comments will be subject to public release. The Village of Oswego is under no obligation to redact any information.
- Give your comment live by phone. Email ttouchette@oswegoil.org or call 630-554-3259 by 4:00 p.m. on the day of the meeting and leave your name, address, phone number, and the topic on which you'd like to speak (address information is optional). Our staff will call you during the meeting and put you on speakerphone so you can provide your comment live. Please be by your phone when the meeting begins at 7:00 p.m. We will let the line ring four times before moving on to the next speaker.

• Residents are strongly encouraged to stay home and participate remotely, however, you may still give public comment in person. If attending in person, members of the public are required to stay six feet from any other person in the room and wear a face covering/mask.

As always, those physically giving public comment are asked to fill out the Public Participation form and abide by the Village's civility code, which is available on the Village's <u>website</u>.

General comments from the public to the Village Board or staff can still be submitted to the Village's email address at info@oswegoil.org, however, these comments will not be read aloud at meetings. In addition, the Village President and Trustees welcome emails and phone calls from constituents.

Social distancing measures in place

For members of the public attending meetings in person, guidelines from the Illinois Department of Public Health and the Department of Commerce & Economic Opportunity will remain in effect. These include but are not limited to:

FISCAL IMPACT:

To purchase a 24 camera program under a 5 year contract will cost approximately \$123,357.00. (Year 1 - \$68,500, Year 2 - \$11,880, Year 3 - \$16,632, Year 4 - \$11,880 & Year 5 - 11,880).

BACKGROUND:

On October 20, 2020, police department staff provided the Village Board of Trustees an overview of Police Body Worn Cameras and how they can potentially be used in police operations. During the presentation, trustees had follow-up questions that staff was requested to bring back information for further discussion.

DISCUSSION:

Staff has developed a presentation to address the questions that were asked by the Village Board of Trustees regarding the implementation of BWC's. The bullets below encompass the questions



FISCAL IMPACT:

Modifications would likely require a change to the overnight parking signage throughout the Village. The cost will include new signs to be made and staff will need to install them at each existing location.

BACKGROUND:

On October 6, 2020, the Village Board had discussion regarding the history of the current overnight parking ordinance 9-4-16. The Village Board also had discussion on possibly modifying the provisions set forth in the current ordinance during weekends. General discussion occurred and staff was presented with additional questions regarding enforcement of the ordinance which would be answered at a later meeting. Staff was also requested to obtain information regarding complaints received by residents to Village staff about issues pertaining to the current overnight parking ordinance while the ordinance was suspended due to the COVID pandemic. Staff was also directed to check in with the Oswego Fire Protection District on any concerns they might have with relaxing some of the provisions of the ordinance.

DISCUSSION:

Police Department staff contact the Oswego Fire Protection District and inquired about concerns relating to relaxing the overnight parking ordinance. They indicated that they have no issue with any changes to the ordinance as long as the on-street parking does not restrict the ability to get their vehicles down a roadway regardless of day or night hours.

Staff researched complaints received to the Village through the See-Click-Fix online portal regarding overnight parking complaints. Since the implementation of the See-Click-Fix program in October of 2014, approximately 118 complaints have been received specific to overnight parking violations through October 14, 2020. 18 of the 118 total complaints were received between April 1, 2020 and September 30, 2020 which was the time period the ordinance was suspended due to COVID.

The data below illustrates enforcement efforts by the police department of the overnight parking ordinance.

BACKGROUND:

At the September 15, 2020 Village Board meeting, staff was requested to provide an overview of the overnight on street parking restriction ordinance and the history behind the development for the Village Board to discuss at a Committee of the Whole meeting. Staff was also requested to provide information on the current parking exemption process.

In February 2004, members of the Village Board requested that the Public Safety Committee that was in place at that time discuss the idea of restricting parking on Village streets during overnight hours. During the preliminary discussions regarding overnight parking, staff supported the concept of restricting overnight on street parking to assist with crime prevention, clear site lines on roadways and snow plowing. In June 2004, the Homeowner Confederation was advised that a few of the new subdivisions in the Village that were being developed were restricting overnight parking on streets. The Homeowner Confederation was requested to provide feedback from other

homeowner associations regarding interest in the development of an ordinance that restricted overnight parking on streets. Due to minimal feedback, the Village through the water billing sent out surveys asking for residents to indicate if they were in support or against an overnight parking restriction on streets. The survey broke the question into two geographic areas of the Village which was "Original Town" and "Rest of the Village". The results were shared with the Village Board in August 2005 and are shown below. It should be noted, at the time the results were shared with the Village Board, the Village Board had been supporting the parking restriction in all new subdivisions that were developed over the prior year. This included Southbury, Ashcroft, Blackberry Knolls and Churchill Club.

In August 2005, the Village Board was provided a draft ordinance for consideration and the ordinance was passed on September 26, 2005 going into effect on January 1, 2006. The memo and draft ordinance presented to the Village Board on September 6, 2005 for first read is attached.

DISCUSSION:

Police Department

The police department has been managing the overnight parking restriction since 2006 regarding enforcement and processing overnight parking exemptions. Currently, the police department does not enforce the overnight parking restriction on the following weekends throughout the year:

- Easter: Friday Monday
- Memorial Day Weekend: Friday Monday
- July 1 July 5
- Labor Day Weekend: Friday Monday
- Thanksgiving Weekend: Wednesday Monday
- December 22 January 2
- PrairieFest: Friday Monday

The police department also has a provision in place that allows for overnight parking exemptions by individual residence. A resident has the ability to contact the police department and request an exemption for a vehicle to park on the street overnight. Each address has the ability to request up

to 30 nights of exemptions over the course of a calendar year. In 2019, the police department processed approximately 4,544 overnight parking exemption requests from 1,514 unique addresses which represents approximately 1.3% of the total exemptions allowed with approximately 11,000 homes in the Village. A breakdown by day of the week exemptions were used in 2019 is illustrate below.



Information below illustrates overnight parking restriction in surrounding communities.

Public Works

Village Code prohibits vehicles from being parked on Village streets between the hours of two o'clock (2:00) A.M and six o'clock (6:00) AM on any day, except during an emergency (9-4-16). The end of the prohibition at 6:00 AM coincides with the start of construction hours (4-10-1). This timing effectively prohibits construction vehicles from arriving at the site and parking on the street prior to the start of work. The constructions hours section of the Code prohibits idling of equipment before 6:00 AM.

Village Code also prohibits parking on streets where there is one inch or more of snow for streets in the central business district (9-4-8A) or two inches or more of snow everywhere else (9-4-8B). This provision is in place to allow plows to clear the roadway from curb-to-curb while limiting potential damaged to vehicles parking the road. For snowfall at night, crews start clearing roads between 2:00 AM and 4:00 AM to clear the streets prior to the start of school. Public Works Department does worry about the snowfall depth triggering removal of vehicles in the middle of the night due to the overnight parking prohibition.

RECOMMENDATION:

Staff believes the current ordinance in place works well for the Village. Staff feels overnight parking restriction conditions residents to park on their driveways rather than the street during non-restricted times which assists with roadways being clear during snow removal. The overnight restriction also makes a clearer sight line when officers are patrolling neighborhoods during overnight hours.

VILLAGE-WIDE 2:00 – 6:00 AM PARKING RESTRICTIONS

The Parking Restriction Ordinance was presented to the Board at the August 15, 2005 Committee of the Whole meeting. At that meeting there was discussion about the ordinance but no changes or concerns were discussed as to the language of the ordinance. As you may recall, the survey results had 1,852 residents voting in favor of the proposed parking restriction, and 1,087 voting against it.

If this proposal is approved, the penalty structure would be similar to other parking ordinances and would start with a \$10.00 fine for the first offense and then progress from that point. The ordinance does have a section for temporary approval of overnight parking that requires the resident to contact the Police Department for approval prior to parking overnight in the restricted areas.

The Village Attorney has prepared an ordinance for your review and consideration. As you review this proposal, please note in Section 1, (B), 1 and 2 has the areas of the Village that will be excluded from this proposed parking restriction.

This is only the first read of the ordinance, and if the Board agrees I would like to have the second read of the ordinance at the September 26, 2005 Board meeting.

ORDINANCE	NO.	05	

AN ORDINANCE PROHIBITING OVERNIGHT PARKING

WHEREAS, vehicles parked overnight along streets within the Village impede police protection, snow removal and other Village operations; and

WHEREAS, the President and Board of Trustees find that it would be in the best interests of the citizens of the Village of Oswego to prohibit overnight parking along streets within the Village.

NOW BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OSWEGO, KENDALL COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1:

That Title 9, Chapter 4 of the Code of Ordinances for the Village of Oswego be and the same is hereby amended by the addition of Section 9-4-16 as follows:

9-4-16: **OVERNIGHT PARKING:**

- (A) Overnight Parking Prohibited: It shall be unlawful for the driver of any vehicle to park said vehicle, or to permit said vehicle to be parked, on any street in the Village between the hours of two o'clock (2:00) A.M. and six o'clock (6:00) A.M. of any day, except in an emergency.
- (B) Exceptions: Due to the prevailing design of streets and/or driveways within the following areas, overnight parking shall be permitted therein:

(C) Temporary Waiver: The Chief of Police or the watch commander is authorized to temporarily waive the parking restrictions in this Section upon request and good cause shown and upon determination that such waiver will not adversely affect the safety of life or property.

SECTION 2: REPEALER

All ordinances or parts of ordinances in conflict with any of the provisions of this Ordinance shall be and the same are hereby repealed.

SECTION 3: SEVERABILITY

This Ordinance, and every provision hereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this Ordinance void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs, provisions and sections and parts of phrases, clauses, sentences, paragraphs, provisions and sections not ruled void or unconstitutional shall continue in full force and effect.

SECTION 4: EFFECTIVE DATE

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
