Ms. Zine stated the applicant is requesting approval of a Major Amendment to Lot 1 of Orchard Plaza Final Plan of PUD to allow for the development of a Popeyes restaurant with a drivethrough. Ms. Zine stated the property is currently vacant pending development and was previously approved for the development of a Burger King restaurant.

Ms. Zine stated the proposed new structure will be approximately 3,230 square feet and 19 feet tall, with a setback approximately 96 feet from Orchard Road. Ms. Zine stated the change in building location is greater than 10 feet, primarily due to the lack of a patio in front of the new Popeyes building. Ms. Zine stated due to the size, height, and location of the new building, a Major PUD Amendment is required.

Ms. Zine reviewed the applicant's proposed signage and the staff recommendations to ensure Village sign code compliance. Ms. Zine stated staff believes the proposed changes to the PUD are in general compliance with the Village's Zoning Ordinance and Subdivision regulations and would recommend approval of the request for a Major PUD Amendment subject to final staff approval of the engineering plans and subject to the following conditions:

- 1. Reduce the size of the front (east) elevation "POPEYES Louisiana Kitchen" to comply with the Village's sign code.
- 2. Reduce the size of the rear (west) elevation "POPEYES Louisiana Kitchen" to comply with the Village's sign code and limit the height of the sign to two feet.
- 3. Eliminate the electronic message board sign on the proposed monument sign.
- 4. The painted "Love That Chicken" mural be allowed only as a painted mural and not as any other construction type of signage.
- 5. On the south elevation, eliminate the "POPEYES" letter sign; only the round logo sign is allowed.
