CALL TO ORDER

President Gail E. Johnson called the meeting to order at 6:00 p.m.

ROLL CALL

NEW BUSINESS

F.1. Review the Wolf Crossing Corridor Design Guidelines

Director Hughes addressed the Board regarding the Wolf Crossing corridor design guidelines. The Village has been working since July 2016 to complete Phase I engineering for Wolfs Crossing improvements. Phase I engineering involves establishing the purpose and need for the project; identifying the preferred alternative including alignment, profile, and right-of-way needs; determining preliminary drainage requirements; investigating potential environmental, cultural, and historical impacts; and gathering and responding to public input.

The design team held public meetings on October 5, 2016 and June 29, 2017. The Village established the Wolfs Crossing Corridor Advisory Team (WolfCAT) comprised of interested stakeholders including corridor residents, homeowners associate representatives, business owners, and other government agencies. The WolfCAT met January 11, 2017, March 23, 2017, and September 28, 2017. During each meeting, the group reviewed concepts for discussion such as identification of problem areas; potential locations of detention basins; options for intersection control; typical sections; and landscape concepts. The preferred alternative includes five (5) signalized intersections and four (4) roundabouts

The goal of the Wolf Crossing Corridor Design Guidelines is to provide a roadmap for the Village and the development community to understand the improvement requirements for the Wolf Crossing corridor. The standards set forth in this document are intended to be adopted as the planning guide for the future improvement of the roadway. In summary, the guidelines establish:

- The roadway will be 5 lanes from Eola Road to Southbury Boulevard and 3 lanes from Southbury Boulevard to Route 34/71.
- There will be lighted intersections at Roth Road and the entrance to Oswego East High School
- Traffic roundabouts are proposed for Southbury Boulevard, Douglas Road, Fifth Street, and Harvey Road
- The ultimate cross section of the road will contain an 8-foot-wide multi-use/bicycle path on one side and a sidewalk on the other side of the road
- There will be a landscaped median containing native species with consistent plant elements throughout the corridor
- Lights will be concentrated at the intersections
- Stormwater basins will need to be established along the roadway to provide necessary detention for the road improvements as well as providing visually appealing elements to the overall design
- Design elements will be included in the final development that incorporates themes that were referenced during the public outreach portion of the analysis. These include the Lincoln Highway, Native American Heritage, Agricultural history, the Fox River and Nature, and the use of quarry stone.

Formal adoption of the guidelines will serve as a planning tool for the Village to implement the Wolf Crossing improvements through the use of grants, development contributions, and Village investment.

Board and staff discussion focused on goals; pedestrian and bicycle friendly; integration with the environment; establishing a sense of space; roundabout not practical at Roth Road or entrance to Oswego East; 11 foot road width versus 12 foot; not a lot of truck traffic; draining water into the medians; 8 foot bike and pedestrian path on the north side; traditional 5 foot sidewalk on the south side; whether there will be more truck traffic; Wolf Crossing will be the school boundary line; school district was ok with the roundabouts; no issue with busses and the narrower roads; native vegetation will be planted; will not light the entire road; heavily landscaped; minimal maintenance; noise studies completed; one house is affected; not incorporating a noise wall; creating scenic vistas; creating pocket parks; roundabouts allow better visibility to on-coming traffic; landscaping the center median of the roundabout; no pedestrian crossing at the roundabouts; artwork in the median; project design report; right-of-way; storm sewers; drainage; realignment of Douglas Road; traffic concerns at Secretariat; working on Phase I for two years; after final approval of Phase I, can start Phase II; land acquisition; starting construction at Harvey Road; needing to pressure IDOT to put money into the project; traffic higher at eastern corridor; \$2.5 million for Phase II; need to close funding gap of \$5.5 million; funding is the issue; seeking additional grants; residents want the Village to purchase their homes now; need to put funds towards the design and not acquiring property now; long distance bikers will still use the roads and not the paths; typical elements; technical design; constructing over multiple years and phases; would take advantage of a capital bill; could do bonds and loans; capital funds geared for downtown currently. There was no further discussion.
