F.1. Presentation on Village and Library Collaboration: Oswegro(w): Entrepreneurs and Small Business Center.

Economic Development Director Cole presented the Oswegro(w) Entrepreneurship Center collaboration to the Board. The Library and the Village partnered to launch Oswegro(w) with the mission of providing resources for entrepreneurs and small businesses that otherwise may not have access to physical space, helpful software, and business mentorship. The objective is to nurture all types of business in Oswego. Oswegro(w) is dependent on strategic partnerships. The Library has been the most significant partner offering space and bearing the cost of the software licenses. Free workshops and classes are likely to be offered via the Women's Business Center of Aurora. Waubonsee Community College has been helpful in providing guidance and recommendations.

Oswegro(w) started with three questions:

- What does Oswego's small business, entrepreneurs, and workforce need?
- What will they need in the future?
- What resources and strengths does Oswego already have in place?

The Future Economy

The economy and workforce have changed significantly. There are trends in the domestic economy towards free lancing or the "gig"; also called the "uber"- economy.

- The number of small and personal business in the US will increase by 7 million
- 40% of the American workforce are projected to be freelancers by 2020
- Oswego has 295 registered home based and small businesses in 2016

• National trends are reflected in Oswego's workforce and economy

Oswegro(w) is still in the formation stage, but the progress and response received has been exciting. Director Cole thanked the Library District for their help and support.

Board and staff discussion focused on the collaboration being a great idea; Library is training staff on the software; services will be provided to everyone, not just small business owners; may be expanded to employees who want to learn the skills; great opportunity for entrepreneurs; whether there will be opportunities to teach people basics of programming and coding; marrying supply and demand; raspberry pi programming; Library has programs currently.
