INVESTIGATIONS

Investigation Spotlight

In December of 2021, Officers were dispatched to a gas station for the report of an aggravated battery. The victim was sitting in his vehicle and the suspect approached the victim's vehicle and began to punch the victim in the facial area and body repeatedly. The victim exited his vehicle and the suspect continued hitting the victim in the face and back of the head with a closed fist. The suspect then entered his vehicle and left the gas station prior to police arriving on the scene. The victim was taken to Rush Copley Hospital for treatment for his injuries. The suspect was contacted and refused to cooperate with the investigation. In March of 2022, the Detective obtained charges and the suspect was charged with two counts of Class 3 Felony Aggravated Battery.
