Dan, from Seasons of Southbury, addressed the Board regarding the bond release scheduled for approval under tonight's Consent Agenda; there are still punch list items that need to be completed; sidewalks are not completed; sidewalks are crumbling; Lennar has told them they were coming back to complete, but have not; foundation and drainage issues; no final asphalt; damage to curbs; issues with sod, mulch and drainage at the dog park; plants and trees have died; some have been dead for three years; if the bond is released, then they have no help and are stuck holding the bill; townhomes are depleting; \$100,000-\$150,000 in costs to the HOA; they cannot afford the costs; please help and do not release the bond.

Taryn Laseter addressed the Board regarding the bond release scheduled for approval under tonight's Consent Agenda; last of the foundations are poured; fears Lennar will cut and run once the final foundations are done; concerns with what the properties will look like in ten years; hopes the Board shares in her concerns; HOA meets quarterly and the Board members are welcome to attend.

NEW BUSINESS

K.1 Ordinance Granting a First Amendment to the Final Planned Unit Development (PUD) for The Reserve at Hudson Crossing North Building to Allow for Alterations to the Approved Exterior Elevations. Ordinance No. 22-37

Dave Patzelt, from Shodeen, was present to answer questions.

Board, staff and Shodeen representative discussion focused on the difference in construction of the north building; south building was constructed as pre-cast; north building will have concrete cast onsite; length of time and cost of pre-cast has increased; both structures will be concrete; north building will be masonry brick; brick on all four sides; both buildings will architecturally the same; siding and brick tone will be different; north building will be more of a red brick tone; didn't want to duplicate because of pre-cast versus built in place; not wanting the north building to look like there was a mistake; pour in place was not considered with the south building; pour in place helps with the construction timeline; pre-cast is a year out; whether there is a delay from the original schedule; leasing on south building went faster than expected; south building is 94.32% leased; tenants that are leaving are the ones having a home built; will not notice the concrete difference on the interior of the parking garage; exterior bricks will be the difference; will not see bolts with the pour in place; will be no loss in structural integrity; still needs to be designed the same for seismic; to the untrained eye, you won't see the difference; testing firm, along with Village staff, will be on-site to test, monitor, and inspect; applying for a permit for a start date in August or September of this year; will be an 18 month to two year build; pre-cast issue is affecting the entire country; if choosing pre-cast the construction will be a year out. There was no further discussion.
