## **DESCRIPTION OF WORK**

The Village of Oswego is seeking a contractor to apply crack fill, selectively patch, and apply bituminous surface treatment, class A2 for eight miles of asphalt path. Work shall be in accordance with Sections 403 and 451 of the Illinois Department of Transportation (IDOT) Standard Specifications for Road and Bridge Construction, 2016 Edition, and the Supplemental Specifications and Recurring Special Provisions, dated March 1, 2021.

The timing of crack sealing and sealcoating for paths shall be coordinated at least 48 hours in advance with the designated Village representative.
