PUBLIC FORUM

Public Forum was opened at 6:01 p.m.

Gerald Struve addressed the Board regarding information on water management in the new development behind his house in Southbury; whether there is enough caution being taken because of the flooding issues.

Dan Bergan addressed the Board regarding the Piper Glen development; he previously provided the Board with pictures from the April 2013 flooding issue; Piper Glen shows similar elevations as his home; Village staff and M/I Homes answered some of his questions and was encouraged with their solutions but is still concerned with the development and flooding; he proposed the adding of additional landscape between his home and Piper Glen.

Dan Fograse addressed the Board regarding the progress on the dedication of Lakeshore; he reviewed the plat of survey for Piper Glen and the potential flooding issues; he asked whether we have a civil engineer on staff or if a civil engineer has looked at the plans; asked that the lines be double checked;

elevation is low in Southbury and high in Piper Glen; some elevations are level. Administrator Di Santo noted we have a stormwater expert on staff along with third party consultants looking at this development.

There was no one else who requested to speak. The public forum was closed at 6:07 p.m.

G.1 Piper Glen

a) Ordinance Authorizing Entering into an Annexation Agreement with M/I Homes of Chicago, LLC for the Piper Glen Development Located at the South of Wolfs Crossing Road Between Douglas Road Extended and Southbury Boulevard; Subject to Attorney Review

Board and staff discussion focused on concerns with the annexation; Village Attorney provided an Attorney-Client privileged letter to the Board regarding the question of prohibiting rental properties as part of the annexation agreement; a Trustee noted that the letter did not appear to address the question; concerns with developers changing the script and turning developments into rentals; would like to table the Piper Glen annexation and have Village attorneys research into further options; Fair Housing Act does not apply to property not in the Village limits; other workarounds previous to annexation; feels the answer is rushed.

A motion was made by Trustee Kuhrt and seconded by Trustee Thomas to table the Ordinance Authorizing Entering into an Annexation Agreement with M/I Homes of Chicago, LLC for the Piper Glen Development Located at the South of Wolfs Crossing Road Between Douglas Road Extended and Southbury Boulevard.

The motion failed by a roll call vote with two (2) are votes and four (4) nay votes.

Additional Board and staff discussion focused on developer is addressing the stormwater issue and has a solution; full faith in Village staff, FEMA and IDNR reviews; stormwater management is challenging; appears to be in design standards; elevated velocities; look at other options for stormwater on both sides and bring solutions back to the Board for more explanation and discussion; can be a safety issue; important to educate the Board on velocities; safety is the biggest thing; bring back before final approval to explain stormwater and channel; find something that may be a better design; need further discussion on what was looked at; alternative analysis on floods. There was no further discussion.
