- 4. QUESTIONS:
 - a. Q: 300 fire hydrants per year is correct? 300 x 4fy = 1200
 A: This is approximate based on the price per hydrant. We do not know what the hydrant painting budget is for the coming years.
 - b. Q: We found 3 contradictions in the document respect to the bid bond. At the DEMANDSTAR page says BID BONE: NONE; In the document, page 4 says: 2. A 10% bid bond must be submitted with the bid. page 10 says: 8.Bid Bond: Each bid shall be accompanied by a bid security in an amount of five thousand dollars (\$5,000) in the form of a certified or bank cashier's check or bid bond. A: The \$5,000 is the bid bond due with the bid.
 - c. Q: Tnemec Series V10-99 Primer was discontinued 1 year ago and Tnemec Series 2Hs Tnemec-Gloss is backorder for more than 4 mounths.A: Our supply contact (Taylor Coatings Sales) has indicated both products are available.
 - d. Q: Can we substitute this material for Rustoleum V7400 High Performance System Primer and Paint or Sherwin Williams Pro-Cryl Primer and SW Sher-Cryl Paint.
 - A: These are both suitable substitutes in the event Tnemec V10-99 Primer and Tnemec Series 2Hs Tneme-Gloss are unavailable
 - e. Q: What is the age of the hydrants? Or do you have any maintenance records that can confirm the hydrants in question we're sandblasted and repainted before? If this information is unavailable, or the hydrants are older than 1980, we would need to conduct a lead test on the paint.
 - A: All hydrants are newer than 1980. All fire hydrants prior to 1980 have been sand blasted and painted in previous years.

- f. Q: For our materials (paint/blast media), would we be able to use your facility to store materials throughout the course of the project? Is any parking for equipment/trucks/dumpster available?
 - A: We have allowed the past contractor to store equipment and materials at our facilities. The amount of vehicle and materials stored may be limited.
- g. Q: If there are 2900 total hydrants with an estimate of doing 300 per year, are we basing this contract to be a total of 10 years?A: No the contract is for 2 years (FY24 and FY25) with the option of an additional 2 years (FY26 and FY27).
