J.1 Ordinance Authorizing the Approval of a First Amendment to a Purchase and Sale Agreement with Field to Beans LLC for Certain Property Located East of the Intersection of Illinois Route 71 and Washington Street – Scooter's Coffee. **Ordinance No. 23-92**

Director Leighty addressed the Board regarding an amendment to the agreement. The Village Board approved a Purchase and Sale Agreement (PSA) with Scooter's Coffee at the June 27, 2023 Board meeting which outlined the terms by which Scooter's would purchase the property back from the Village to make way for their proposed development at Rt. 71 and Washington. As stipulated in the PSA, Scooter's was required to purchase the property from the Village before the end of their 180-day inspection period set to expire on December 24, 2023. Scooter's is close to being ready for final approval but due to a few loose ends with IDOT and their lender, they will need to extend the PSA to allow for additional time. The terms of the existing PSA will all remain in place apart from the inspection period. The purchase price is still set at \$35,000 and the Village will maintain a right of reverter which would return ownership to the Village if the developer does not comply with the terms of the RDA. The inspection period has been extended to March 23, 2024, which represents a 90-day extension from the original deadline.

J.3 2023 Property Tax Levy

a) Public Hearing to Comply with Truth in Taxation Act 35 ILCS 200/18-60, 18-65 for the Village of Oswego.

The public hearing was opened at 7:46 p.m. to Comply with Truth in Taxation Act 35 ILCS 200/18-60, 18-65 for the Village of Oswego.

Director Lamberg addressed the Board regarding tax levy for 2023. 100% of the tax is directed to the Police Pension Fund. The levy will be filed with the County Clerks by December 22, 2023. The estimated equalized assessed value (EAV) increase is 6.91% for the entire Village of Oswego. This amount may change slightly due to assessment objections up until the final EAV is determined. The current levy is \$1,654,800. The following table provides options for the 2023 tax levy based on the estimated EAV as of December 5, 2023, received from the Kendall County Supervisor of Assessments:

- The green line shows what the tax would be if the 2023 tax rate was decreased 2.0% from the final 2022 tax rate as was discussed by the Village Board at the October 17, 2023, Committee of the Whole meeting.
- A 2.00% reduction from the 2022 tax levy rate results in the 2023 proposed tax rate being the lowest it has been since 2010.

Board and staff discussion focused on still on pace to fully fund the pension; can round up; could go more; the EAV was initially higher; don't want to levy more; have been overfunding for at least six years; did a 2% reduction last year; in a position to do more than 3%; 3rd smallest tax amount on the tax bill; do 3%.

The public hearing was closed at 7:54 p.m.

b) Ordinance Providing for the Levying, Assessment and Collection of Taxes for the 2023 Tax Year of the Village of Oswego, Kendall and Will Counties, Illinois. **Ordinance No. 23-93**

Additional Board and staff discussion focused on 3% decrease would be \$1,716,117.00 and would cover the pension plus \$28,097.00; police contribution amount increased 11% last year; would potentially need to keep the levy flat going forward; could fund the Police Pension from the General Fund; whether the Police Pension could be funded through cannabis tax; cannabis revenue has already been incorporated into the budget; it's not a new revenue source; everyone coming to Oswego is paying the sales tax; pension funded through property taxes; one of the biggest rate cuts ever; in good financial shape; opportunity to do this now; lead by example; fixed income limited by state statute; everything is with the state; have no control over what investments are made; assumed rate; used an old formula and stayed conservative; police pension funded in the high 70%. Consensus was to decrease the tax rate to 3%. There was no further discussion.
